Booking rules

- Courts may not be booked more than 2 weeks in advance, except for League matches, Club tournament matches and group coaching.
- A member may only book one court per day. Maximum booking period is 1.5 hours per day. If booking is for Club tournament match (and booking is marked as such) and match is not completed within 1.5 hours, then start of next booking may be delayed.
- A booking lapses if a court is unoccupied 15 minutes after booking start time.
- League matches only: Team captain may change court bookings if necessary (e.g. frosted court).
- Maximise court booking slots during busy periods. e.g. 7.00pm-8.30pm and 8.30pm-10.00pm.
- Junior members may not play under floodlights unless supervised by an adult member.
- Court 6 can be provisionally booked by a member.
 However, this booking may be cancelled at any time (until 6pm on the day before the booking) by a coach should the court be required for coaching. Should the booking be cancelled then an email will be sent to the member.
